CLASS 2 PRODUCTS

- (2) When a military procurement activity receives a military part number request for Class 2 products, the procurement activity must procure suitable Class 1 replacement products in lieu of the Class 2 items.
- (3) A Class 2 part is ordered by the manufacturer's part number. Only that particular manufacturer's approved Class 2 tool can be used with the Class 2 part.
- (4) Class 2 products will not be stocked by the Defense General Supply Center for replacement purposes.
- (5) Class 2 products do require qualification approval. Copies of the Qualifying Activity's approved part number listing must be obtained from the manufacturer. Class 2 products have the same periodic qualification requirements as Class 1 products. A verbal confirmation of a manufacturer's qualification reference number for particular Class 2 products may be obtained from the Qualifying Activity: Telephone (301) 342-0857 or DSN 342-0857.
